BESS project financing options in Argentina 2025



Overview

Today, we are seeing non-recourse project finance for 600+ MW portfolios, mezzanine debt entering the capital stack, and public banks co-financing with private lenders. For developers, asset managers, and financiers alike, this is a call to sophisticate how BESS projects are packaged and financed. How much is a battery energy storage system (BESS) project worth?

The Energy Secretariat of Argentina's Ministry of Economy has launched a global tender for 500 MW of battery energy storage system (BESS) projects in the Metropolitan Area of Buenos Aires' (AMBA) critical nodes. The project's estimated value is \$500 million, with an execution period of 12 to 18 months.

Can battery energy storage modernize Argentina's grid?

Argentina's ambitious push toward grid modernization through battery energy storage has received an enthusiastic response, with CAMMESA (Compañía Administradora del Mercado Mayorista Eléctrico) confirming the submission of 27 project proposals from 15 companies under its AlmaGBA program.

Who will sign the energy storage contracts in Buenos Aires?

The energy storage contracts will be signed with leading electricity distributors in Buenos Aires, Edenor, and Edesur, while the Wholesale Electricity Market Administration Company (CAMMESA) will be the guarantor.

How many MW of battery energy storage will be deployed in Buenos Aires?

The initiative aims to deploy 500 MW of battery energy storage systems (BESS) in the Greater Buenos Aires Area (GBA), but the submitted capacity has far exceeded expectations—reaching a combined 1,347 MW.

What are Rigi-approved solar projects in Argentina?

Notably, the first RIGI-approved project is YPF Luz's 305 MW solar photovoltaic park in Mendoza, with an investment of US\$211 million. Vaca Muerta, holding the world's second-largest gas reserves, represents a cornerstone of

Argentina's energy strategy.

What is Argentina's energy contingency plan?

The project is a part of Argentina's energy contingency plan instituted in October 2024 to stabilize and improve its power infrastructure. The plan includes short, medium, and long-term measures to recover electricity systems facing critical issues.

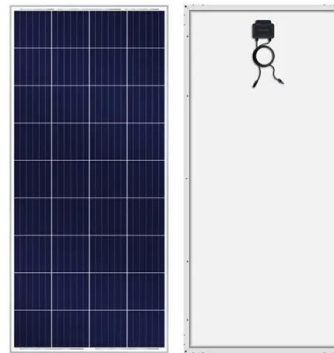

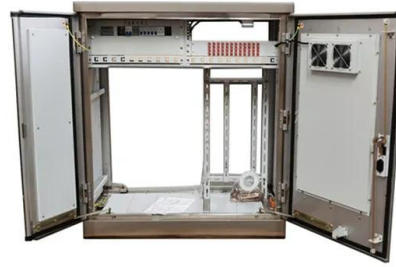
