Expected ROI of enterprise ESS system project in Croatia 2026



Overview

How will investment be supported by the EU?

Investment will be supported by the use of EU structural and Recovery and Resilience funds, along with more favourable financing conditions. Private consumption growth will slow as real income growth moderates. Risks are related to geopolitical tensions, global energy price rises and weakening demand from key trading partners.

How has financial conditions impacted borrowing costs in Croatia?

Easier financial conditions in the euro area have not yet passed through to borrowing costs in Croatia. Nevertheless, bank lending to households has been rising strongly, by around 11% (year-on-year) in September. On the other hand, growth in lending to firms has been declining in 2024, to around 4.7% in September, down from 12% in 2023.

What can we expect from the euro & Schengen economy in 2023?

Integration into the euro- and Schengen areas at the start of 2023 are testament to progress, and are providing a further fillip to the economy. Ensuring that fiscal policy is counter-cyclical and that lending supports productive investments can help contain inflationary pressures and sustain growth.

How has external demand impacted Croatia's Economy?

Weaker external demand has moderated exports of goods and services. Tourist stays during the peak season increased at a lower rate than a year earlier. Easier financial conditions in the euro area have not yet passed through to borrowing costs in Croatia.

How many ESS peer reviews were conducted in 2022?

The third round of ESS peer reviews was carried out until the beginning of September 2023. Eight ESS peer reviews took place from the end of June to

December 2021, four of them virtually and four physically. Twelve peer reviews were conducted in 2022, all in a physical or hybrid mode.

What does Croatia's fiscalization law mean for B2B e-invoicing & archiving?

Its goal is to facilitate the transition to B2B e-invoicing, archiving, and digital accounting. Croatia's Fiscalization Law establishes the mandatory use of electronic invoicing (eInvoice) and real-time transaction reporting (e-Reporting) as of January 1, 2026.

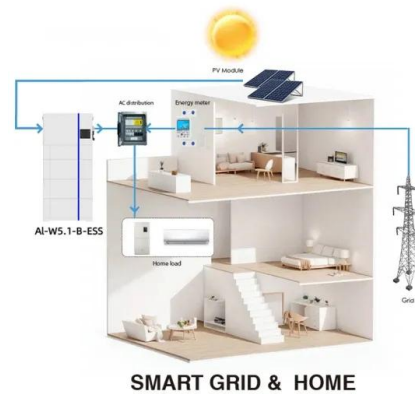

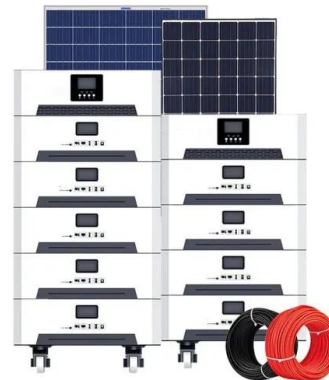
