The government proposes allocating NOK 1,265 million to the support scheme for electricity and district heating, called “Norway Price”, for households in 2025. The plan is to introduce the support scheme from the 1st of October 2025. ‘The Norway Price is an important measure to allow people across.

The government has proposed introducing a fixed price scheme for electricity of NOK 0.40 per kWh (Norway Price or the scheme) from 1 October 2025. The proposed scheme will be a voluntary alternative to the current electricity subsidy scheme that all households and holiday homes will be offered. The.

Substantial parts of the Public Procurement Act and the regulations are based on EU/EEA directives and aim to ensure fair competition and transparency in the procurement process. The different regulations share many common features and are based on the same principles, but they also have some.

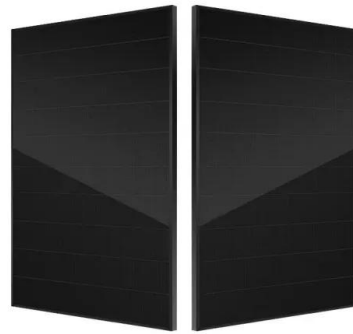

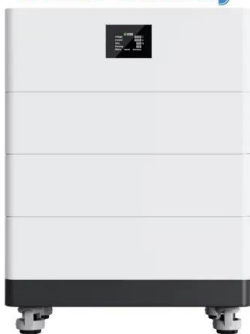

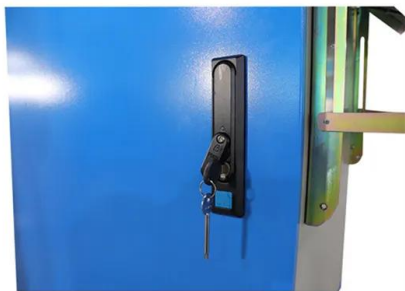
