Special exemptions also apply in cases of urgency or emergency situations, where rapid procurement is required.

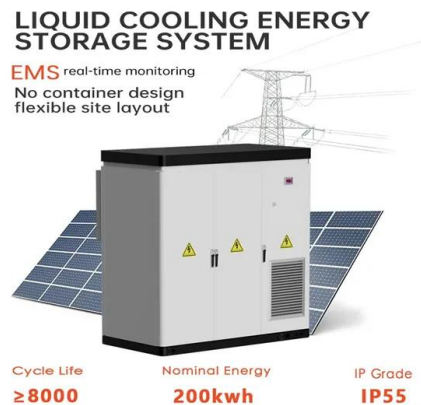

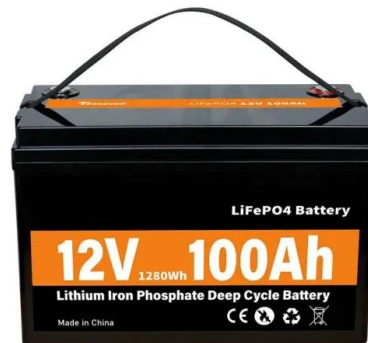
