What is Public Procurement Act in Nepal?

7 The Public Procurement Act proclaimed by the Parliament of Nepal in 2007 aimed to make all procedures, processes, and decisions relating to public procurement transparent, competitive, and fair, with a concern to value for money (toward this, Clause 69 envisaged use of electronic communications for public procurement transactions).

What is government procurement process?

Government procurement process is streamlined and consolidated procurement information available for monitoring and analysis and effective decision making. Public entity sends the formal request as per the e-GP Directives to concerned department or authority for Public Entity registration. These steps complete the registration of a public entity.

What is a single stage 2 envelope (S2E) procurement procedure?

In case of Single Stage Two Envelope (1S2E) procurement procedure for works and RFP evaluation of consultancy service, technical and financial evaluation should be done separately. Financial evaluation will be done for those bidders who have been qualified in technical evaluation. The chairman of Bid Evaluation Committee logs into the e-GP system.
