What are the procurement methods prescribed in Norway?

The procurement methods prescribed comprise competitive and less competitive procurement procedures and provide an appropriate range of options to ensure value for money, fairness, transparency, proportionality, and integrity. The Norwegian legal and regulatory framework for public procurement follows the EU directives.

How do procurement decisions work in Norway?

Norway offers a dual-track system for challenging procurement decisions: Complaints to the contracting authority: Possible until contract signing. Norwegian Complaints Board for Public Procurement (KOFA): An administrative body issuing advisory opinions, with power to fine for illegal direct awards.

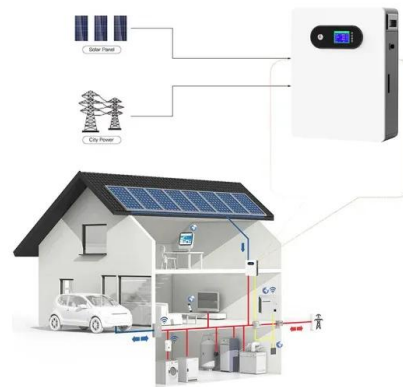

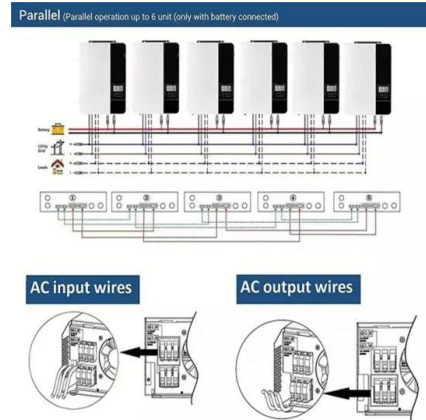
