The French government has awarded 165 projects at an average price of €0.07948 (\$0.09315)/kWh in its latest ground-mounted PV tender. From pv magazine France The French Ministry of Ecological Transition has published the results of the eighth round of the Programmation Pluriannuelle de l'Energie.

Solar projects with a combined capacity of 911.5 MWp have secured the winning status in France's latest tender for ground-mounted photovoltaic (PV) power capacity, which ended with a slight undersubscription. The 92

successful projects were secured at an average price of EUR 81.9 (USD 89.12) per.

The French Ministry of Ecological Transition and Territorial Cohesion has awarded 971MW of ground-mount solar capacity, to 165 projects, in the eighth round of the second. How much does a power plant cost in France?

The French government has selected 329 projects in its latest procurement exercise. Average prices were €77.62/ MWh for large power plants (500 kWp to 8 MWp) and €87.23/MWh for projects below 500 kWp. From pv magazine France.

How did France's new PV power tender work?

France's latest tender for ground-mounted photovoltaic (PV) power capacity saw further price reductions, with 948.3 MWp of projects awarded. The tender, part of the PPE2 multi-year energy procurement program, slightly overshot its target of 925 MWp, with 120 projects securing winning bids.

The Pluriannual Energy Programme (PPE) still sets the target for French photovoltaic capacity at 20.1 GW in 2023 and at least 35.1 GW in 2028.

How many solar panels are recycled in France?

PV is collected for recycling by SOREN in France under the WEEE national legislation. There were 461 sellers subscribing to SOREN in 2023, responsible for putting 5.9 MW of modules on the market (14.5 million modules/330 000 tonnes). 5 200 tonnes was collected, of which 90,5% was sent for recycling (less than 100 MW).
