What are the different types of Bangladesh government procurement?

The most popular categories for Bangladesh government procurement are - Bangladesh Government releases various kinds of tenders - Bangladesh RFP - A document outlining the Bangladeshi government's requirements for a proposed project or service, inviting vendors to submit detailed proposals.

How big is Bangladesh's government procurement market?

Bangladesh's government procurement market is a behemoth, steadily growing to reach over 7.1 trillion BDT (\approx \$71 billion) in 2021. This represents a significant chunk of the nation's GDP, hovering around 12%. The e-GP portal streamlines the process, with over 80% of procurements now conducted online.

What are the new modules of public procurement in E-GP system?

Some new modules of public procurement have been developed and added to e-GP System. These are Tenderer Database, International Competitive Tendering (ICT), Direct Procurement, e-Audit, Framework Agreement, Red Flag Monitoring and Service Procurement.

How has the E-GP system changed the procurement process?

The eGP system has significantly reduced the time required for procurement cycle. Support from the World Bank: The implementation of the e-GP system has been supported by the World Bank as part of the Public Procurement

Reform Project (PPRP-II).
