Who determines the procurement procedure in Turkey?

In Turkish procurement legislation, the determination of the procurement procedure is the duty of the “contracting officer” on behalf of the contracting authority. In order to increase competition and participation in tendering, one of the “basic tender procedure”, namely the “open procedure” and the “restricted procedure”, should be selected.

How are public procurement tenders regulated?

Such tenders are regulated in Public Procurement Law No. 4734, which entered into force in 2002.

What are the rules governing tenders in Turkey?

Distinct laws govern tenders that generate revenue for the state and those that incur expenses to the state in the Turkish procurement system. Tenders generating revenue for the state are regulated under the State Procurement Law No. 2886. Such tenders may include the sale and leasing of movable and immovable property belonging to the state.

How is SSB procurement financed?

SSB procurement is financed off-budget, through special taxes, and is not subject to public procurement laws. KIK approves public tender conditions and evaluates complaints of wrongdoing in public procurement tenders for a certain fee as specified by the relevant regulations.

Where can I find government procurement laws & regulations?

The main laws and regulations that regulate government procurement can be found on the Public Procurement Authority (KIK) website. For defense tenders and contracts, the Presidency for Defense Industries (SSB) and the Ministry of National Defense have their own procurement regulations.
