Overview

Are energy storage technologies the key to reducing energy costs?

Energy storage technologies are also the key to lowering energy costs and integrating more renewable power into our grids, fast. If we can get this right, we can hold on to ever-rising quantities of renewable energy we are already harnessing – from our skies, our seas, and the earth itself. The gap to fill is very wide indeed.

Should storage projects be funded?

One large missing piece has been funding. Storage projects are risky investments: high costs, uncertain returns, and a limited track record. Only smart, large-scale, low-cost financing can lower those risks and clear the way for a clean future.

Is storage the key to the Green Energy Revolution?

As the technology for generating renewable energy has advanced at breakneck pace – almost tripling globally between 2011 and 2022 – one thing has become clear: our ability to tap into renewable power has outstripped our ability to store it. Storage is indispensable to the green energy revolution.

What is the gap between merchant Bess & hybrid projects?

As merchant BESS and hybrid projects become increasingly prevalent, the gap between developers using sophisticated modelling platforms and those relying on consultant-only or basic internal models will only widen.

How do I secure debt for Bess & hybrid projects?

Securing debt for BESS and hybrid projects requires a "bankable" revenue forecast from lenders preferred consultants. Developers need their own flexible modelling tools to optimise project design and achieve more favourable financing terms.

How many new storage projects have been approved in the developing world?

Twelve new projects across the developing world have already been approved, including in Bangladesh, Brazil, Colombia, Haiti, Honduras, India, Indonesia, the Maldives, and Ukraine. In the next three years, CIF plans to create 1.8 GW of new storage capacity and integrate an additional 16 GW.

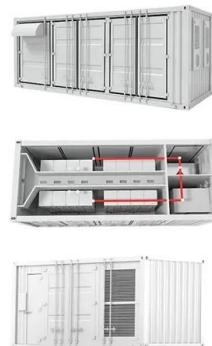
