Let's discuss some of the mandatory benefits offered by the benefits and compensation policy in Ghana: The minimum wage in Ghana stands at 13.53 per day. Hence, the monthly minimum wage for all the employees in Ghana is 365.31 GHS. The standard working hours in Ghana are 40 hours per week, 8 hours per day.

Do employers pay their employees bi-weekly in Ghana?

However, some employers choose to pay their employees on a bi-weekly basis. There are no provisions in the law regarding 13th salaries. The standard workweek in Ghana consists of 40 hours a week and typically is broken down to 8 hours per day for a five-day workweek. The workweek can be increased to 48 hours per week in specific sectors.

What benefits do expat employees get in Ghana?

During their employment in Ghana, employees are entitled to several benefits,

like dental care, health insurance, vision care, family allowance, meal allowance, and fuel allowance. The entitlements of the expat employees also depend on their agreed terms with their employer when they join the company.

How much money can a non-resident make in Ghana?

The maximum contribution is 8,235 GHS. Non-resident individuals are taxed at a flat rate on Ghanaian-sourced income. The daily minimum wage (NDMW) in Ghana is 19.97 GHS. The payroll cycle in Ghana is monthly and payments must be made on the same day of each month and no later than the last working day of each month.
