# Mobile ESS unit project financing options in Poland 2030



## Overview

Can Poland co-finance electricity storage facilities?

Poland's National Fund for Environmental Protection and Water Management (NFOŚiGW) has initiated a call for applications for co-financing electricity storage facilities. The programme, funded by the country's Modernisation Fund, has a budget of more than 4bn zlotys (\$1.02bn).

Are energy storage systems a new technology in Poland?

Energy storage systems are a relatively new technology in the Polish capacity market. They have participated in two auctions so far: making their official debut in 2022 (with 2027 delivery year) and subsequently dominating the competition in the 2023 auction.

How much money is needed to support Poland's Bess project?

The European Commission has approved a EUR1.2 billion aid package to support Poland's rollout of BESS, aiming to establish at least 5.4 GWh of storage capacity.

How much PLN will be distributed under the energy subsidy scheme?

A total of PLN 4 billion (\$1 billion) will be distributed under the subsidy scheme by the end of 2025 in a bid to bring online more than 5 GWh of energy storage projects by 2028.

What is the European Commission subsidy scheme?

The European Commission authorized the subsidy scheme in October 2024 to the tune of €1.2 billion in a bid to support the installation of at least 5.4 GWh of new electricity storage facilities.

How will the Polish aid package work?

The Polish aid package will be funded by both the Modernisation Fund and the Recovery and Resilience Facility. Poland's energy grid remains heavily dependent on carbon-intensive sources, with around 70% of its electricity generation in 2023 still reliant on coal and gas.

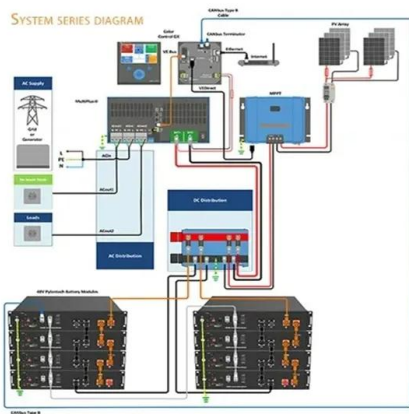

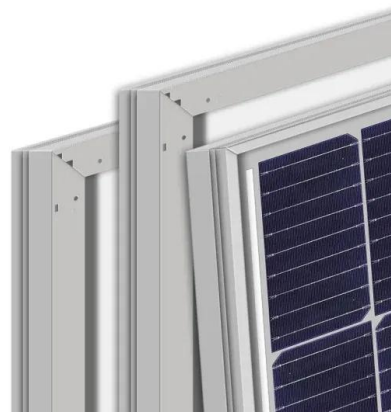

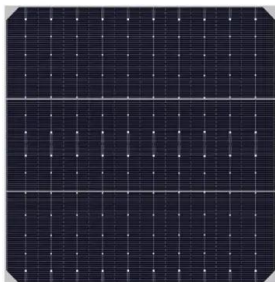
