Greece has officially launched its third tender for battery energy storage capacity, aiming to allocate 200 MW of projects eligible for subsidies of up to 200,000 euros per MWh. This tender marks the final phase of Greece's ambitious 1 GW program, which is designed to support the development of.

The regulator said the auction was highly competitive, leading to an average tender price of €47,680 (\$51,506)/MW per year. Greece's energy storage auction program awards contracts-for-difference (CfD) over periods of 10 years. The submitted bids were capped at €115,000/MW per year, with the lowest.

Before the end of 2024, Greece intends to provide subsidies for standalone battery projects of 200 MW in total via the third auction. The Ministry of Environment and Energy issued a decree determining the available operating power quota. Together with the support awarded in the first two auctions.

The Greek Regulatory Authority for Energy, Waste, and Water (RAAEY) has launched the country's third auction for standalone, grid-scale, front-of-the-meter battery energy storage systems. The auction seeks to award 200 MW of battery storage projects, 100 MW less than initially announced when the 1.

How many MW of new battery storage capacity does Greece have?
