Onsite PPA: The earliest onsite PPA contracts are usually adaptations of US- or UK-based PPA templates and such contracts are often highly convoluted and

not fit for the Singapore solar regime, which is a simplified regulatory regime to accelerate solar adoption, but there are no feed-in tariffs or government subsidies for renewable energy use.

How many PV installations are there in Singapore?

The island has grid-connected roughly 3,000 PV installations over the last decade. “But we cannot rest on our laurels,” said Chun Sing. The government will continue to support PV through the SolarNova programme and rooftop solar deployment.

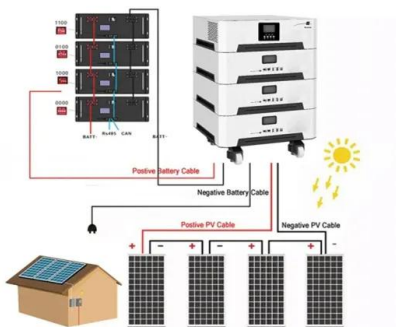
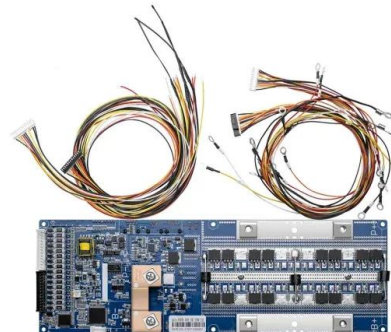
