Employers must provide 2-3 weeks of paid annual leave, 7 days of sick leave, 12 weeks of maternity leave (partially paid), severance (up to 48 weeks' pay for managers), and 11 paid public holidays. Partnering with Remote People's Employer of Record services streamlines adherence to Bahamas labor.

Employees in The Bahamas are entitled to paid leave after one year of service to their employer. The length of holiday allowance depends on years of service and is usually 10 to 15 days. Employees in The Bahamas are generally entitled to one to two weeks of paid sick leave per year. Medical records.

The national minimum wage of the Bahamas was increased at the start of 2023, from BSD 210 per week to BSD 260 per week (approx. £205, €240). The subject of minimum wage remains a focus in Bahamas politics, and so further increases in the near future cannot be ruled out. There is no legal.
