Israel's Electricity Authority has unveiled an ambitious new rooftop solar initiative, aiming to inject up to 1.6 GW of capacity by 2030. Announced recently, this program is a significant step in supporting Israel's transition to clean energy, leveraging the potential of solar power by. Together, they will generate 1.6 gigawatts of installed capacity — a tenth of what's needed to reach the government's goal of generating 30 percent of electricity from renewables by 2030. Energy Minister Eli Cohen told a press conference in Jerusalem that solar panels promised a return on investment of at least 15% annually over 25 years.

The press conference heard that the ministry will launch an extensive public awareness-raising campaign, a new, user-friendly internet site, school programs about the importance of renewable energy, and an increase in solar implementation centers in local authorities to help guide residents through solar installation.

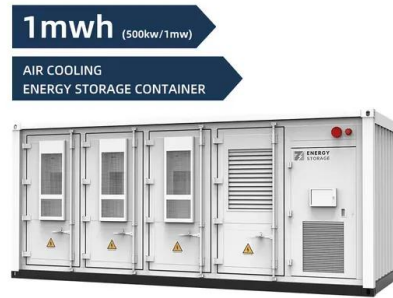
