How much zloty will be provided in 2026?

The call for proposal's budget is 893,460,000 zloty. The aid will be provided in the form of subsidies of up to 45% of eligible costs which may be spent by 30

June 2026 at the latest. Proposals may be submitted until 14 March 2025.
